Chief's Report.

Chief Marrs reported on the following:

- Station 18 Remodel Update There is a mandatory bidder walk-thru tomorrow for Stations 18 and 19.
- FBC Update We are beginning to receive calls and are starting the appeals process.
- District 2 Interlocal Agreement (ILA) The ILA with District 2 needs to be renegotiated regarding the full-time staffing of AID 318. Commissioner Hiatt will be the NHFD's representative in the negotiations.

- South Park Flooding Chief Marrs thanked Commissioner Giba for the heads-up on this issue. We have visited the area several times and not found damage due to the recent flooding in the unincorporated area. Commissioner Giba inquired about new homeless encampments in the unincorporated area. Chief Marrs is not aware of any.
- CARES Car Chief Marrs introduced Lindsey Mueller, our new CARES program social worker who started this week and went on her first call today. She shared some of her background and was welcomed by the Board.
- COVID Update We continue to have occasional firefighters out with COVID-19. However, it is a small manageable number and is not affecting operations.
- AID 318 Upstaffing Chief Marrs provided 2022 Call Volume by station. He will update the data quarterly.
