Chief Marrs reported on the following:

- Station Remodel Update Chief Marrs announced that we will be advertising for bids in the Seattle Times and Puget Sound Business Journal in the next few weeks.
- Levy Correction –The King County Assessor made an error in 2022 and overlevied the amount due to NHFD by approximately \$39K. We have agreed to repay the money over the next three years.
- Holiday Outreach Our holiday outreach Is in full swing. Delivery to 25 families with lots of children will be on December 21st. Approximately 14 families of those families live in the North Highline Fire District.
- COVID Update Chief Marrs updated the Board on COVID. We have one firefighter in COVID quarantine. According to Medical Director Dr. Rea, COVID is still impacting hospital capacity. The Bivalent Booster is highly recommended.
- Discussion of the Rescheduling of the December Regular Meeting Because our regular meeting falls on December 26, 2022, a special meeting will be scheduled for December 19, 2022 at 5 pm.
